- \$400 entry fee per class due by July 15<sup>th</sup> or
- \$800 late entry fee per class due by September 1<sup>st</sup>
- \$25 fee per horse for Office/Drug Testing Charge**
- A change in ownership after completed entry form is received will result in a \$75 change fee.

*\*Entry fees received less than two weeks prior to the class must be paid with certified funds. (cash, money order or cashier's check)*

*\*\*All credit card transactions will be charged a 3% convenience fee.*
